



Goodyear Ballpark's 15 Years of Photos Contest Official Rules

- a. No purchase necessary to enter or win.
- b. Prizes:
 - a. Weekly prize (one each week for the duration of the contest): Goodyear Ballpark commemorative photo frame
 - b. Grand Prize (one): ballpark suite (15 tickets) for the game on March 17, 2024.
- c. Contest begins at noon on January 24, 2024 and ends at 5 p.m. on February 21, 2024. To enter the contest, participants must submit a photo taken at Goodyear Ballpark during the past 15 years online at www.goodyearbp.com/photo. One winner will be selected each week, and winner will receive a Goodyear Ballpark commemorative photo frame. and announced publicly on Goodyear Ballpark's social media channels (Facebook, Twitter and Instagram). One Grand Prize winner will be selected on February 22, 2024 and notified via the email address provided with their entry. Grand Prize is a suite for the March 17, 2024 game that includes 15 suite tickets, food and nonalcoholic beverages for 15 people. The Grand Prize winner has 24 hours to respond via email to Goodyear Ballpark to claim their prize. If winner does not meet the deadline, the Ballpark shall move on to the next winner. If the winner cannot claim the Grand Prize for March 17, 2024, the Ballpark will offer an alternative date. If there is not an alternate date with a suite available, Ballpark will make available 15 tickets in another seating area, and Ballpark Bucks of similar value for 15 people.
- d. No more than one entry allowed per person.
- e. Eligibility: Entrants must be legal US residents, at least 18 years or older at the time of entry.
- f. Multiple entries by means of software-generated or other automated processes will be disregarded and voided in city's sole discretion. In the event of a dispute as to any registration, the account holder of contest management software account used to register will be deemed to be the registrant.
- g. Participation: By participating, entrants agree to be bound by these Official Rules and the decisions of the City of Goodyear. The City of Goodyear reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this contest as solely determined by the City of Goodyear. In the event the contest is compromised by a virus, non-authorized human intervention, tampering or other causes beyond the reasonable control of the City of Goodyear which corrupts or impairs the administration, security, fairness or proper operation of the contest, the City of Goodyear reserves the right in its sole discretion to suspend, modify or terminate the contest. Should the contest be terminated prior to the stated expiration date, the City of Goodyear reserves the right to award prizes based on the entries received before the termination date.
- h. Publicity Release: By participating in the contest, each entrant acknowledges that his/her entry constitutes that entrant's consent to use, publish, reproduce and for all purposes, including publicity, promotion and advertising, in any media (including without limitation, the Internet, television or offline promotions), each winner's name, voice, likeness, and any portion thereof, as well as the winner's photo submission, each extending throughout the universe and in perpetuity without further compensation, credit or right of review or approval, except where prohibited by law.
- i. Photo Release: By submitting a photo entry to this contest, entrant relinquishes all rights and photo credits related to that photo.
 1. All photos must be original work, taken by the entrants. No third party may own or control any materials the photo contains, and the photo must not infringe upon the trademark, copyright, moral rights, intellectual rights, or rights of privacy of any entity or person.
 2. The photo must be in its original state and cannot be altered in any way, including but not limited to removing, adding, reversing, or distorting subjects within the frame.
 3. Violators will be removed from the contest, stripped of any prize(s), and banned from entering future contests.
 4. Entries will not be accepted unless submitted via the official contest channel. Entries not submitted through the proper channel will be deleted.
 5. Entries will be judged by Goodyear Ballpark. All decisions are final. Goodyear Ballpark reserves the right to disqualify any entry that is deemed inappropriate or does not conform to stated contest rules.
 6. By entering the contest, entrants agree that photos submitted can be used by the City of Goodyear and Goodyear Ballpark for advertising purposes.
- j. Submissions will not be accepted once the deadline lapses.
- k. The prize must be collected by the winner and is nontransferable.
